Speakers Biographies

Nicole L Sawyer, PsyD is a licensed clinical psychologist in Exeter, New Hampshire. She has been in clinical practice since 2005 and works exclusively with public safety professionals and first responder agencies. Dr. Sawyer currently serves as the supporting psychologist for the NH State Police Peer Support Unit, she provides clinical support for various Critical Incident Stress Management (CISM) teams across the state and is an instructor for the NAMI-NH Crisis Intervention Training (CIT) program. She is the professional crisis intervention specialist for the Seacoast Emergency Response Team (SERT), the Strafford County Regional Tactical Operations Unit (SCRTOU), and the NH State Police SWAT (NHSP-CNU), responding alongside law enforcement in the community. In addition to her field roles, she provides psychological consultation, assessment, and evaluation for fire, police and corrections agencies across NH. Dr. Sawyer is known best for her straight-talking and candid trainings and workshops, taking a direct approach to the psychological challenges faced by public safety professionals and first responders over the course of their careers.

Michael O'Brian is the Fire Chief for the Brighton Area Fire Authority in Michigan, overseeing fire protection across 74 square miles with five stations. He also leads Code Concepts Group, a top consulting firm helping communities with technical projects. Chief O'Brian serves on the board of the International Association of Fire Chiefs as the International Director of the Fire and Life Safety Section. He was President of the Michigan Association of Fire Chiefs from 2013-2017. He holds a Bachelor of Science in Public Safety Administration from Eastern Michigan University, where he also teaches as an adjunct instructor. A dedicated member of multiple ICC and NFPA technical committees, Chief O'Brian is a past chair of the Fire Code Action Committee with the International Code Council. He is a national leader in fire service preparedness for lithium-ion batteries and a passionate advocate for firefighter health and wellness.

Sam Heaton led the 1700+ personnel of Cobb County (GA) Department of Public Safety agencies which consist of Police, Fire & Emergency Services, 911 Communications, Emergency Management, and Animal Services. Cobb County is located northwest of Atlanta and is the third most populous county in the state with approximately 780,000 people. Heaton began his career with Cobb County Fire & Emergency Services in October 1985. He worked his way through the ranks of the department from a firefighter/paramedic to his appointment to Chief of the Department in May 2008. After six successful years as the Fire Chief, he was appointed as the Director of Public Safety for Cobb County. This appointment was a first for the county as all previous Directors came from a law enforcement background.

After five years as the Public Safety Director and 33+ years of total service, he retired in March 2019 and began consulting work with various Public Safety entities in the areas of leadership and management training, diversity training, and strategic planning. He is currently working with the City of Powder Springs overseeing the departments of Police, Parks, Code Enforcement, and Courts.

Heaton co-created a class titled "Courageous Conversation" and it continues to be shared with departments across the nation and at the IAFC Fire Service Executive program. He has also been instrumental in the continued growth of the Cobb County Safety Village which provides personal safety and fire life safety training to over 20,000 students each year. Heaton has an associate's degree in Fire Science and a bachelor's degree in public safety administration. He is a graduate of the Atlanta Regional Commission's Regional Leadership Institute and a graduate of the University of Georgia's Government Management program.

During his career he served in various roles with the Metro Atlanta Fire Chiefs Association and Georgia Fire Chiefs Association and in 2018 Governor Nathan Deal appointed him to serve on the Georgia Board of Public Safety where he served until his retirement.

Today Heaton continues to teach and serve through his consulting business and locally he serves as the President of the Cobb County Retired Employees Association, the Vice-Chair of the Cobb County Employees Pension Board, serves on the Board of the Marietta Youth Museum and the Cobb County Safety Village Foundation. When not working he spends time with his family (wife, three daughters, and four grandkids) and traveling.

William “Bill” Tanks was appointed to the role City Manager for the City of Mableton Georgia on April 1st, 2024. In his role as the chief executive and administrative officer, he is responsible to the city council for the administration of all city affairs.

He previously served as the Executive Director for Public Services for the City of Powder Springs, Georgia from December of 2021 until April of 2024. In his Powder Springs role he served as second in command to the city manager and provided executive leadership to the three department heads of the Powder Springs Police Department, The Powder Springs Parks Department, and the Powder Springs Municipal Court. Prior to his service to the City of Powder Springs, he served as the Agency Director for Public Services for Cobb County Government and provided executive leadership to the seven department heads that led the Cobb County Senior Services, Cobb County Library System, Cobb County Elections, UGA Cobb Extension Offices, Cobb Sustainability Waste and Beautification, Cobb Parks Department, and the South Cobb Government Services Center. Prior to serving as the Agency Director for Public Services with Cobb County Government he served as an Executive Chief Officer for Cobb County Fire and Emergency Services. His combined eleven years of senior executive experience in local government was preceded with twenty-one years of faithful service to the citizens of Cobb County as a Cobb County Firefighter, Fire Officer, Chief Officer and paramedic. Bill Tanks also served in the United States Navy and Navy Reserves for 20 years until his retirement in 2006 as a Chief Petty Officer. He has received many awards for his service in the military, public safety, and local government; however, his greatest satisfaction has come from the countless awards and recognitions of the teams he has been privileged to lead.

He holds two master’s degrees, one bachelor’s degree, and an associate degree. His community involvement spans more than 30 years and he has served on several local boards either as a member, treasurer or chair. He and his wife, Lee Ann Tanks, currently live in the West Cobb area. He is the father of four adult children and grandfather of one college student and two elementary students. He teaches leadership and team building across the country and has conducted presentations on the subjects of team building, transformational leadership, and most notably Courageous Conversations.

Kenneth W. Richards, Jr. MS, EFO, CFO has been a member of the Fire Service for 49 years, starting in 1976 at the age of 14 as a Junior Firefighter in Old Mystic, CT. Ken has served as the career Fire Chief / Fire Marshal of the Old Mystic Fire Department for 32 years. He is the past President of the New England Division of The International Fire Chiefs Association (NEDIAFC), and a 32-year member of the NFPA. Serving as a member of the Fire Service Training Technical Committee for 21 years and its Chair for the past 14 years. Chief Richards earned his Bachelor of Science in Fire Technology from Charter Oak State College and holds a Master of Science in Executive Fire Service Leadership from Grand Canyon University. He is also a 1999 graduate of the National Fire Academy Executive Fire Officer Program, a Certified Chief Officer from the Center for Public Safety Excellence, a Fire Officer IV NFPA Standards and a Fire Instructor III NFPA Standards.

As the Fire Chief of the Orange County Fire Authority (OCFA), **Brian Fennessy** leads more than 1,800 firefighters and non-sworn personnel who collectively serve 2 million residents across 23 cities and unincorporated county. Chief Fennessy began his career in 1978 with the USFS and BLM working as a hotshot crew-member and ultimately crew superintendent. In 1990, Fennessy joined the San Diego Fire-Rescue Department and ultimately became Chief of Department in 2015. In 2018, he was appointed to Fire Chief of the OCFA. Chief Fennessy currently serves as Chair of the FIRESCOPE Board of Directors; represents California as a member of the Western Fire Chiefs Association Wildland Fire Policy Committee; represents the nine West Division FEMA Urban Search & Rescue Task Forces; and President of the California Fire Chiefs Association. In 2022, Chief Fennessy was recognized as CalChiefs Fire Chief of the Year and in 2023, the International Association of Fire Chief's Career Fire Chief of the Year.

Dave Emanuel, MPA, EFO, CFO, is the chief of the Durham, NH Fire Department, serving the Town of Durham and the University of New Hampshire (UNH). Chief Emanuel has over 30 years of career and volunteer fire and EMS experience as a firefighter, company officer, and chief officer, in both labor and management leadership positions, is an instructor for the NH Fire Academy, and is a nationally recognized leadership speaker.

Chief Emanuel holds a Master of Public Administration and bachelor's degrees in business administration and civil engineering from the University of New Hampshire and is a licensed NH Professional Engineer. He is a credentialed Chief Fire Officer by the Center for Public Safety Excellence (CPSE) and a graduate of the National Fire Academy's Executive Fire Officer Program. Chief Emanuel has contributed to the fire service by serving as a Commissioner for the Commission for Professional Credentialing of the CPSE, currently on the Board of Directors for the IAFC Safety, Health, and Survival Section (SHSS), and the Executive Boards of the New Hampshire Association of Fire Chiefs and Seacoast Chiefs Fire Officer Mutual Aid District. He has worked with the IAFC Bullying Behavior Prevention Taskforce since 2017 and chaired the Taskforce since 2019. Having served as both a career and volunteer chief officer, he understands that addressing firefighter safety, health, and survival challenges are essential for our first responders in all levels of emergency services. He strives to network and leverage connections on the local, state, and national level to build relationships and promote education and training for industry progress.

Speakers Biographies

Lee Price is a 35-year veteran of emergency services and is currently a Risk Management Training Manager for McNeil & Co. in Cortland, NY. During his career he has served in a wide range of roles in fire and EMS for paid, volunteer and combination agencies, including 23 years as a career Firefighter and Fire Captain/Paramedic. Having been a Certified fire and EMS instructor for more than two decades, Lee has also been an EMS training program director as well as serviced on regional EMS committees and executive boards. Lee currently serves on 2 NFPA technical committees and the NVFC Red Ribbon committee for firefighter safety.

Chief Greg Flynn joined the fire service in 1998. He has served West Bloomfield as a firefighter/paramedic, EMS Division Captain, Assistant Chief, and Fire Chief. Flynn holds a bachelor's degree in public safety studies, is a graduate of the National Fire Academy Executive Fire Officer Program, and possesses a Master's degree from the Naval Postgraduate School – Center for Homeland Defense & Security in Monterey, California.

Chris Barron currently serves as the Fire Chief of the Travis County Emergency Services District #5 / Manchaca Fire/Rescue department located just south of Austin, Texas.

Chief Barron has worked diligently in the fire service for over 34 years, serving as Chief for 24 of those years, to increase service delivery performances in the local area and around the state. He has used several performance improvement programs to lead ESD#5 from an all volunteer department, ISO Class 7/9, to a fully staffed ISO Class #2 department.

Barron retired from the State Firefighters' and Fire Marshals' Association where he served for almost 15 years as the Executive Director. Barron was responsible for the administration and oversight of the 23,000-member organization representing first responders in Texas and central and south America. While serving as Executive Director, he was responsible for several initiatives benefiting Texas first responders including the Texas wildfire fund and Hurricane Harvie relief programs, authoring and successfully awarded three Department of Homeland Security SAFER grants and oversight of the construction of the new headquarters building.

In 2019, Chief Barron started his own consulting company to assist emergency services across the nation on their challenges, improving performance and recruitment/retention efforts. His focus with his business is to assist fire departments facing challenging times with staffing, volunteer workforce reductions, organizational changes, and leadership challenges. He is also working with departments on performing fire department assessments, funding resources, and developing marketing and strategic plans.

Barron has received numerous leadership and organizational awards for his leadership including the John Buckman Leadership Award, the IAFC/VCOS Recruitment/Retention Award and in 2014, Chief Barron was awarded the International Association of Fire Chiefs Chief of the Year Award amongst a nationwide group of colleagues.

Barron holds numerous fire certifications, and an associates in fire protection, bachelor's and a master's degree in business administration.

Speakers Biographies

Chelsea Rubadou is an engineer for the National Fire Protection Association (NFPA) and currently works as a staff liaison and subject matter expert for standards dedicated to community risk reduction, data analysis, and fire prevention programs. Her goal is to develop contemporary resources and materials for stakeholders in these important spaces. Previously at NFPA, Chelsea co-developed an innovative community risk assessment tool designed to help CRR professionals implement high-quality CRR without the need of a local data science team. She also serves on the Commission for Fire Accreditation International. Chelsea earned her master's degree in Fire Protection Engineering from Worcester Polytechnic Institute (WPI).

Karen Berard-Reed, M.Ed., is the Community Risk Reduction Director at the National Fire Protection Association where she leads strategic delivery of CRR initiatives. Karen develops innovative tools and resources to assist stakeholders who are focused on data and standards-driven processes to improve community safety. Her contributions include training, partnership-building, and critical tools to support CRR efforts such as CRAIG 1300™, the NFPA Community Risk Assessment Insight Generator and the CRR Kitchen Table, a monthly virtual gathering of prevention-minded professionals. Karen previously managed NFPA's high-risk outreach activities and created safety education materials for young children, older adults, and underserved communities. Karen serves on the IAFC Fire and Life Safety Section Board of Directors, the NASFM Core CRR team, the Vision 20/20 steering committee and has served as an instructor at the National Fire Academy. Before coming to the NFPA, Karen worked in the health promotion field in K-12, higher education, and community settings.

John Oates is the President and CEO of the International Public Safety Data Institute, the fire service's leader in data and analytics. As CEO, he is responsible for growth, adoption, and continuous improvement of the NFORS Analytics, Exposure Tracker and FireCARES programs. Prior to being appointed I-PSDI CEO in November 2021, John served as Chief of the East Hartford, Connecticut Fire Department for 13 years. Prior to that, he served in West Hartford, CT for 20 years, reaching the rank of Battalion Chief. John has a BS from Franklin Pierce University, a MS from Oklahoma State University, is a graduate of the National Fire Academy Executive Fire Officer Program and holds numerous professional certifications. He has been an Advocate for the NFFF's Everyone Goes Home Program since the inception of the 16 Firefighter Life Safety Initiatives. He serves the First Responder Center for Excellence as member of the Behavioral Health Advisory Committee. Chief Oates serves as a member of the NFPA 3000 Active Shooter/Hostile Event Response Technical Committee and the Technical Committee for Safety at Motorsports Venues (NFPA 610) where he served as Chairman from 2005 until 2016.

Tom Jenkins serves as a Senior Advisor / Research Manager for UL Fire Safety Research Institute on the NERIS project. Before joining the NERIS team, he was the Fire Chief for the City of Rogers (AR). In that capacity he led over 160 career firefighters and successfully attained accreditation from the Center for Public Safety Excellence and the Commission on Accreditation of Ambulance Services. Chief Jenkins was asked by Governors Beebe and Hutchison to serve on several state commissions and groups, including the Trauma Advisory Council, Firefighter Cancer Benefit Review Panel, and the Safe Schools Commission. He has served as a professor for Drury University, Northwest Arkansas Community College, Tulsa Community College, and Oklahoma State University. In 2015, Chief Jenkins was elected to serve on the Board of Directors for the International Association of Fire Chiefs as the Second Vice President. In 2017 and 2018, he served as President and Chairman of the Board of the IAFC.

THE SPEAKER:

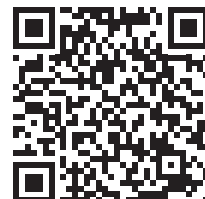
